



DH Runners Privacy Policy

This policy sets out the basis on which any personal data we collect from you, or that you provide to us, will be processed by us. Please read the following carefully to understand our views and practices regarding your personal data and how we will treat it.

1. Consent

By becoming a member of DH Runners or by signing up for DH Runners organized events you are accepting and consenting to the practices described in this policy.

As a club member we will contact you via e-mail from time to time with important club news.

2. Information that we may collect

We may collect and process the following data about you:

2.1 You may give us information about you by filling in forms on our website, filling in forms on 3rd party sites used to manage event entries or by corresponding with us by phone, e-mail or otherwise. This includes information you provide when you register as a DH Runners member or sign up for specific events or courses.

2.2 The information you give us may include your name, address, e-mail address and phone number, gender, age, club membership and, we may collect your credit card information (e.g., your credit card number and expiration date, billing address, etc.) some of which may constitute personal data, to secure certain payments. If a user voluntarily provides that information in connection with registration for an event or otherwise, it will be available to us and will be held by us in accordance with this Privacy Policy. In addition, such information may be delivered to the Governing body of the sport or event certification body of the applicable event in accordance with our "Disclosure of Information" statement below.

3. Disclosure of Information

3.1 We only share your information with third parties in the following circumstances:

For Club Membership, this information will also be supplied to England Athletics .

Personal Information as part of any DH Runners Event and may be passed to the governing body or affiliated organisation for the purpose of insurance, licences or for publishing results.

All payments directly on the DH Runners website will be processed by Snipcart using the Stripe gateway. Snipcart & Stripes' privacy policy and terms and conditions will apply to the processing of such payments.

3.2 We may be required to disclose or share your personal data in order to comply with any legal obligation.

3.3 We will take all steps reasonably necessary to ensure that your data is treated securely and in accordance with this privacy policy. Unfortunately, the transmission of information via the internet is not completely secure. Although we will do our best to protect your personal data, we cannot guarantee the security of your data transmitted to our site; any transmission is at your own risk. Once we have received your information, we will use strict procedures and security features to try to prevent unauthorised access.

4. Your Rights

We will not use your personal data for marketing purposes. We will only share your personal data in accordance with Section 3 with governing bodies or affiliated organisations, who will have their own privacy policies. You have the right to access your own information held by the club, this should be done following the Subject Access Requests procedure, (see section 5)

5. Subject Access Requests

The GDPR gives you the right to access information held about you. Requests for copies of personal data from individual club members will be responded to within one calendar month of receipt.

6. Data Protection Responsibilities

The responsibility for data protection compliance is held collectively within the club committee. The same committee is also responsible for the investigation of any data breaches.
